



Commercial Cooking Rebates NORTH & CENTRAL TEXAS

Rebates for natural gas appliances are provided by Atmos Energy Corporation (Atmos Energy) and administered by Frontier Energy (Frontier). Eligible customers of Atmos Energy will receive rebate payments issued by Frontier after receipt of all required customer documentation.

Convection ovens, steam cookers, griddles and fryers must be on an ENERGY STAR® list of approved products (available at www.energystar.gov) to qualify for rebate payment. Combination ovens, rack ovens, and conveyor ovens are required to be on an Atmos Energy approved list of approved products (available at www.atmosenergy.com/efficiency).

Rebate payments will be issued to eligible program applicants within approximately 4-6 weeks of receipt of all required customer documentation. You can submit your rebate application two ways:
